MINUTES OF MEETING HELD BY CP, DELHI ON 26.3.2020 AT 19.45 PM
IN VIMARSH CONFERENCE HALL, PHQ, DELHI.

The Commissioner of Police, Delhi held a meeting on 26.3.2020 at 1945 hrs in Vimarsh Conference Hall, PHQ, Delhi which was attended by the following officers:


1. Spl.CsP Traffic, Law & Order (N & S), Ops. Licensing & Transport, Security and Crime & Int., Delhi
2. Jt.CP/Spl. Cell and Licensing
3. Addl.CP/Crime (PRO)
4. DCP/Licensing (I/C Helpline, PHQ) and CRO

CP, Delhi passed the following directions/instructions in connection with prevention from COVID-19:-

1. All DCsP of Districts/Units must brief their staff to take adequate precautions relating to COVID-19. The supervisory officers must provide them masks, sanitizers and ensure that their barracks are also sanitized.
2. Daily feedback regarding health status of all police personnel be sent to Spl.CP/Ops for perusal of CP, Delhi.
3. All the district DCsP must liaise with the hospitals in their jurisdiction in advance for ensuring proper treatment and also provide all facilities to the family members if at all any case is reported in future despite all precautions being taken. The lists of such hospitals be shared with DCP/GA, HQ and Incharge, Delhi Police Helpline, PHQ. We must keep appropriate readiness to deal with any case of infection to our staff in future.
4. Beat officers be directed to visit the registered senior citizens and facilitate them to stay comfortably in their homes. In this regard they should also co-ordinate with the NGO's which are already attached with local police to provide services to such senior citizens. The beat officers should visit senior citizens and ascertain whether they are maintaining good health and are safe. DCsP/District should monitor the same closely on daily basis.
5. A close coordination be maintained with RWAs and MWAs to encourage the residents/shopkeepers for successful operation of lockdown. The local field officers should become part of whatsapp groups of RWA's and MWA's in order to solve their problems and to obtain information, which can be helpful to us.

6. The guidelines regarding funerals, i.e. congregation of not more than 20 persons, should be followed. Further, no gathering for prayer meeting etc. is permissible.
7. All religious places should be directed to be closed so that there is no gathering of devotees. SHOs should liaise with caretakers of religious places in this regard.

These instructions must be complied with.


